NOTICE OF PUBLIC HEARING TO CONSIDER THREE PROPOSED ORDINANCES TO AMEND THE 2010 SAN JUAN COUNTY BUDGET FOR EMERGENCY APPROPRIATIONS, FOR SUPPLEMENTAL APPROPRIATIONS, AND TO SET THE 2010 BEGINNING CASH BALANCES.

NOTICE IS HEREBY GIVEN by the San Juan County Council that the Council will conduct a public hearing for the purpose of receiving testimony on proposed ordinances: Ordinance Amending San Juan County's 2010 Budget for Emergency Appropriations, Ordinance Amending San Juan County's 2010 Budget for Supplemental Appropriations, and Ordinance Amending San Juan County's 2010 Budget for Beginning Cash Balances. The public hearing will be held in the Council Hearing Room at 55 Second Street, Friday Harbor, Washington, on Tuesday, March 30th, 2010, beginning at 10:45 a.m. The hearing may be continued from time to time and place to place as may be desired by the Council without additional written notice.

The ordinances will revise Ordinance 39-2009 by adjusting budgeted beginning cash to reflect actual beginning cash balances; to add supplemental revenues and expenditures to the Current Expense and Grants Funds; to amend the appropriations for the Current Expense Fund, Land Bank Conservation, Land Bank Stewardship, Veteran's Assistance, Parks, Capital Improvement, Auditor's Document Preservation, Criminal Justice Receiving, Multipurpose Facilities, Solid Waste, Storm Water, Public Facilities Improvement, Information Services, and Solid Waste Funds; and to revise all payroll Funds for decreased medical premium costs as detailed in the Ordinances.

At the hearing, members of the public will be invited to speak and/or provide written statements regarding the proposed ordinance. After the public testimony portion of the hearing, the Council members will deliberate and consider modifications to the ordinances that are proposed by members of the public, county employees or the Council. The proposed ordinances may then be adopted with or without modifications.

All persons wishing to be heard on this matter are encouraged to attend. Written comments may be submitted in advance of the hearing by mail or at the hearing by delivery in person. Please send 8 copies of all written comments to the Clerk of the San Juan County Council at 55 Second Street Friday Harbor, WA 98250 (360) 378-2898. The ordinance(s) are filed at the office of the County Council, 55 Second Street, Friday Harbor, WA.
