CAMPING RESERVATIONS

- *Reservations are not required* for camping at any of the San Juan County Parks, but are *strongly recommended* during the summer.
- *Campsite reservations* may be made a minimum of 5 days and a maximum of 90 days in advance of stay. *Reservations are accepted from **March 18, 2009** through October 15, 2009. **These conditions are likely to change in 2010.***
- *To make a campsite reservation*, please visit www.sanjuanco.com/parks at any time and click on “Webervations” in the left-hand navigation bar (*link will not appear until March 18*). The Parks administration staff will charge your Visa or MasterCard for the *full campsite payment plus a \$10.00 reservation fee*. We will send a reservation confirmation via e-mail Monday-Friday only (no weekend or holiday service). If you cannot access the internet to make a reservation, please call Parks Administration at 360-378-8420, weekdays, 10am–noon Pacific Time.
- *\$10.00 reservation fee is fully non-refundable.*
- The *campsite fee* allows for up to 4 people and 1 vehicle per site. *Parking* allowed in designated parking areas only. *Additional charges* will be assessed for extra people and extra vehicles and *are due at check-in*, payable only by cash or check (U.S. Dollars).
- **A NOTE OF CAUTION - RESERVATIONS CANNOT BE CHANGED!** With this new online system, we will no longer be able to modify your reservation. Once you have booked, that reservation can only be cancelled (per our cancellation policy-below), not changed. To reserve for different dates, you must start the Webervations process anew. *Please make sure that the dates you reserve are the dates you truly want!*
- *Cancellations* made 30+ days in advance of the first reserved day will result in a 10% cancellation fee; 14-29 days is a 25% fee; 3-13 days is 50%, less than 72 hours is non-refundable. *No refunds* issued at the park.
- To *cancel a reservation* or advise us of your late arrival (later than noon *the next day*), please call (360) 378-8420; 72 hours notice is appreciated.
- All parties *must check-in* upon arrival at park.
- *Maximum RV/trailer length* at San Juan County Park is 25 feet; maximum length at Odlin County Park is 22 feet in sites 1-9 and 30' only in sites 6, 8, & 10. RV's and trailers are not advisable at Shaw County Park. Measurement includes slide-outs and hitch/tow bar/fifth wheel, if applicable.
- *RV & trailer space is limited* and may require special advance arrangements. RV's are not allowed in some sites. *If you plan to bring an RV, you must select a suitable site when you make your reservation.* No hook-ups are available. *Oversize RV's/campers/trailers will be refused a campsite.*
- *Maximum stay limit* is 14 days; minimum of 7 days between maximum stays.
- *Groups* of nine to 30 people will be accommodated in special Group Camp areas on a space available basis (Shaw County Park can only accommodate 15 people). Groups must call (360) 378-8420 to reserve space, starting in January.
- *Commercial operators* are required to obtain a permit from the Parks and Recreation Director (360-378-8420) to use any San Juan County park for a business-related purpose. Park use without a valid permit is grounds for denial of use privileges.
