

RESOLUTION NO. 22 - 2010

AUTHORIZING THE TEMPORARY CLOSURE OF A PORTION OF
NORTH BEACH ROAD ON ORCAS ISLAND
FOR THE ORCAS ISLAND FARMERS MARKET

BACKGROUND:

1. The Orcas Island Farmers Market Association has requested the closure of a portion of North Beach Road for the purpose of the Farmers Market on May 29, 2010.
2. Village Square, the area traditionally used for the Farmers Market, is being used for the "Bite of Orcas" on May 29, 2010.
3. The request is that portion of North Beach Road:
 - a. From A Street (East) to Doty's Market Place.
 - b. From 7:30 am to 4:00 pm
 - c. Saturday, May 29, 2010.
4. Chapter 10.04 of San Juan County Code adopts by reference the Washington Model Traffic Ordinance (WAC 308-330).
5. San Juan County Ordinance 46-2009 requires a \$100.00 nonrefundable fee for a Temporary Road Closure Permit.
6. The petitioners have submitted the \$100.00 fee.
7. WHEREAS, WAC 308-330-270(7) gives the County Council the authority to temporarily close any highway after an investigation by the traffic engineer.
8. The San Juan County Engineer reviewed and recommended temporary closure of said portion of North Beach Road.
9. It will be in the best interest of the citizens of San Juan County to temporarily close said portion of North Beach Road for the Orcas Island Farmers Market.

NOW THEREFORE BE IT RESOLVED, that the County Council approve the temporary closure of North Beach Road under the following conditions:

1. All property owners within the closure area are notified of the proposed closure.
2. Barricades are installed at both ends of the closure.
3. Barricades are staffed to give directions and information.
4. Provisions are made for emergency response through the closed area.
5. Easel boards be placed one week prior to the closure informing the public of the time and date of the proposed closure.

6. The closure is granted as follows:
 - a. From A Street (East) to Doty's Market Place.
 - b. From 7:30 am to 4:00 pm.
 - c. Saturday: May 29, 2010.
7. The County Sheriff be notified three days prior to the event.


