DRAFT DEER HARBOR PARKING ORDINANCE

Draft Deer Harbor Parking Ordinance Draft 3

There is no public parking in Deer Harbor except in designated locations for specific periods of time as indicated. Where parking signs are not present or on private grass or property adjacent to a specified parking area there is no parking.

1) **Parking at the Deer Harbor Bridge** -- No overnight parking at the Bridge

2) **Parking at the triangle near Deer Harbor Road and 4 Winds** --3 hour parking only.

No overnight parking

3) **Parking at the intersection of Windward Way and Deer Harbor Road** -- 3 hour parking only. No overnight parking

4) **Upper Deer Harbor Road** parking is designated with 15 outer island residential permits which must be designated on the vehicles. These vehicles must not constitute abandoned junk motor vehicles as defined by RCW...and further said vehicles are passenger cars as defined by RCW... not motor homes or campers as defined by RCW.... The additionally, public parking is designated: 3 hour parking only. (Marina and Resort parking are private parking and the responsibility of those entities on their private property.)

5) **Parking at the Deer Harbor Post Office** spaces designated US Postal Service Customer -- 15 minute parking

There is no camping in the Deer Harbor Hamlet or in public parking areas.

In the Deer Harbor Hamlet, there is no public parking for trailers, bicycle companies, rental car companies.

No person shall stand, stop or park a vehicle, or allow a vehicle to be parked any part thereof along a road in a designated bike path.

For purpose of enforcement the registered owner of any vehicle or trailer parked contrary to provision of this ordinance shall be deemed to have allowed such vehicle or trailer to be parked in violation hereof.

The San Juan County Sheriff, or their designated representative, shall have the authority to impound any vehicle or trailer as authorized by any statutes of the State of Washington or ordinances of the San Juan County and shall have the authority to impound any vehicles which are parked or left standing in the travel portion of a roadway, within no parking zones as specified in RCW....within an established bicycle path, or at such other location as constitutes a traffic safety hazard.

Any person, firm or corporation who shall violate, or permit, or allow anyone to violate this ordinance, or the registered owner of any vehicle found in violation of this ordinance, shall be guilty of a misdemeanor, and shall upon conviction be fined up to \$500.00
