The Washington State Growth Management Act requires San Juan County (SJC) to periodically update its plan. The plan provides the framework for how the community will grow. The Comprehensive Plan incorporates the community vision into goals and policies. The goals and policies, in turn, guide the community throughout the coming years. The Comprehensive Plan is divided into elements such as Land Use, Housing, Transportation, Capital Facilities, and Utilities. The Comprehensive Plan is the expression of how our community is going to progress into the future.



The Comprehensive Plan exists to guide the County into the future, it must be updated periodically to reflect new conditions in the county.

Over time the analyses and projections that inform the plan no longer cover the entire 20 year planning period and need to incorporate new data as it becomes available.

The update process is intended to refine the Comprehensive Plan so that it better suits our community's needs and vision for the next 20 years.
