

The Comprehensive Plan represents the county's vision for the future. The Comprehensive Plan outlines how our county will respond to changes in the next twenty years. The plan contains a 20 year vision, goals, policies and a land use map. It is the guiding document for new policies and programs.

Why does the Comprehensive plan matter?

- The plan will guide the county to continued success in the face of future challenges.
- The plan guides county policy, shaping elements such as: land use, housing policy, transportation, and shoreline management.

Land Use Designations

Urban Growth Areas

Urban Growth Areas are established as a part of the Comprehensive Plan. These areas are specially marked out as places where increased development is encouraged in an effort to protect agricultural & forest lands.
