Hello Randy,

On September 18, 2015, the Planning Department requested additional detailed information regarding the Runstad applications. These requests were made pursuant to the County's position that the project is no longer vested to the Critical Areas Ordinance in effect at the time the original application was initially submitted. Lee sent two notices requesting supplemental studies and analysis. The due date for information associated with the Shoreline Substantial Development Permit Application is November 17, 2015. However, the due date for the same information that supports the companion Exemption Request is December 17, 2015. The County's information requests are identical in terms of the requested analysis and additional studies. The information needs are substantial and our consultants are working on singular work products that address both the SSDP and the Exemption Request.

Accordingly, I am requesting that the County recognize December 17, 2015, as the due date for both requests for additional information. Please confirm the County that this is acceptable to the County.
