The ballot before you is a veritable lesson in how citizens make law. It includes 15 state measures, 6 local measures, and the election of a State Senator.

At the state level, in addition to twelve Advisory Votes, Washington voters get to vote on one each of an initiative, a referendum, and a Constitutional amendment.

At the local level, measures propose to form and to fund a park and recreation district on Shaw; to authorize excess levies for the Lopez Island Library, the Lopez Solid Waste Disposal District, and the County; and to amend the County Charter to permit biennial budgeting.

The only candidate race that will appear on every ballot in San Juan County is that for State Senator of the 40th District. The incumbent, who was appointed to the position in February, must win by election in November to keep the seat. The Senator is the county’s only voice in the State Senate.

Voters on Orcas will also vote in contested commissioner races for the Port of Orcas and Eastsound Sewer and Water.

This ballot is your chance to make law. Use it.

What is a Ballot “Measure”?

- Measures are anything on a ballot that is not a race between candidates. Measures include initiatives, referenda, Constitutional or Charter amendments, levies, district formations, etc.
- Initiatives are laws proposed (“initiated”) by citizens. State Initiatives may be sent to the Legislature for adoption (in which case they are called Initiatives to the Legislature, or ITLs), or may be sent directly to the ballot for a vote of the people. An ITL that is not adopted by the Legislature is automatically sent to the ballot for a vote of the people.
- Referenda “refer to the people,” for approval or rejection, laws passed by the Legislature. The legislation might have originated as a bill or as an Initiative to the Legislature.
- Constitutional amendments, in Washington, may be initiated only by the Legislature. Even though the initiative process is well known and often used in Washington, it cannot be used to amend the Constitution.
- Advisory Votes are a uniquely Washington measure which give voters the chance to vote on whether the Legislature should have passed a law they already passed. However, unlike referenda, advisory votes have no effect and do not change the law that has passed.

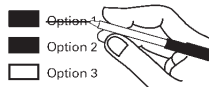
How to vote

Voting more than once for a contest will be an overvote and no votes for that contest will be counted.

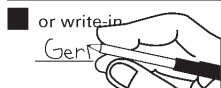
If you make a mistake

- Tear off the stub at the top of the ballot and throw the stub away.
- Mark all contests you wish to vote. **You don't have to vote every issue.**
- Put your finished ballot into the security sleeve.
- Put your security sleeve and ballot into the return envelope.
- Read, sign, and date the Voter's Declaration on the envelope. **We cannot count your ballot unless you sign the declaration.**
- Seal the return envelope.

Explanatory Statement

Since 1995, state law has allowed all counties to adopt an annual or biennial budget process and to change from one process to the other. Presently, San Juan County adopts an annual budget using procedures established by state law and subject to requirements and restrictions in the county charter which has been approved by voters.

Article 7 of the county charter, entitled "Financial Administration," in multiple locations refers to an "annual" budget process. This language has been construed as a limit on the power of the county council to elect a biennial process and a charter amendment is necessary to authorize the county council to use the state-approved process for biennial budgets.

The county council desires to use a biennial budget process for all funds or any selection of funds. This biennial process will include a mid-biennium (annual) review and modifications for the second year of the biennium.

The county council desires to have the flexibility to use biennial budget process. If this process is approved by the voters and the choice is made by the county council, then an annual or biennial budget process may be adopted for future budgets.

The county council is authorized by Section 9.35 of the county charter to adopt an ordinance to propose amendments to the charter for a vote of the people. A "yes" vote is in favor or approve of the charter amendment. A "no" is against the charter an amendment. A majority of those voting must approve this measure.

Argument For

The County Charter refers only to annual budgeting, in order to allow a two year budgeting process a Charter Amendment is required. The change will allow biennial budgeting, it will not require it.

Budgeting for two years at a time has been permitted in Washington counties since 1995. Dozens of cities and counties prepare biennial budgets.

Budgeting takes a substantial amount of time and effort. Implementing a biennial budget will allow more time for county departments to focus on their long term departmental goals and critical work. There will still be a mid-biennium review to make adjustments as needed. The budget process will include considerations for potential increases and decreases in year two of the budget which will result in a flexible and realistic plan.

We expect our county leaders to think strategically. A biennial process will require county officials to think more long term and encourage critical thinking at a programmatic level, resulting in better planning and creating a more efficient focus on programs, services and projects.

Biennial budgeting will require a longer term focus on sustainability. The effects of the decisions in year one will be evident in year two of the budget. This will allow the council to make decisions that will safeguard public interests by adopting a budget that is sustainable over a longer period of time.

We urge you to vote yes on biennial budgeting.

San Juan County voters have previously approved levy lid lifts in 2009 and 2014, each for a period of six years. The Council is returning to the voters for a levy lid lift with for 2020 and subsequent years to bring stability to the county services.

The San Juan County Council has proposed to increase property taxes in the year 2020 by way of a one-time levy lid lift on property tax of 22 cents per \$1000 assessed value to a total of 85 cents per \$1000 of assessed value and then in subsequent years continue that new levy amount subject to the limit factors set out by state law.

If approved by the voters, the existing levy lid lift for the year 2020 will be canceled and this levy lid lift will be used in its place.

The 2020 levy is expected to generate about \$1,700,000. This is a one-time levy lid lift, and future increases of the levy amount will be subject to the limit factors set out in Chapter 84.55 RCW. The limit factor is typically limited to one percent (1%) plus add-ons including new construction and subject to maximum limits.

The resolution adopted by the County Council sets out the programs and activities that are to be allocated funds from the proceeds of this levy lid lift. The appropriations will be dedicated for the year 2020 at the amounts shown below and thereafter with increases to the levy amount resulting from the limit factor in Chapter 84.55 RCW, but subject to adjustment as set forth in the resolution. Because of the stability and duration of this levy, the resolution provides that appropriations in subsequent years may be adjusted as a result of 1) changes in the fiscal health of the county; 2) changes in state and federal funding used in conjunction with the levy lift programs; and 3) changes in the status of any non-profit that is funded.

The programs are similar to those previously approved, but the amounts have been adjusted to reflect costs of services as follows:

a. Senior Services including meals on San Juan, Orcas, and Lopez Islands, in an amount of

approximately \$404,000;

b. WSU Extension programs, including 4-H, Master Gardeners, Agricultural Resources Committee and agricultural programs, in an amount of approximately \$228,000;

c. Maintenance and operation of county parks, in an amount of approximately \$326,00;

d. General fund support of the San Juan County Fair, in an amount of approximately \$51,000;

e. Public health services on San Juan, Orcas, and Lopez Islands, in an amount of approximately \$145,000;

f. Corrections-Work Release, in an amount of approximately \$54,000;

g. Victim Services-Prosecutor, in an amount of approximately \$68,000;

h. Emergency Management, in an amount of approximately \$140,000;

i. Maintenance of county buildings and grounds, in an amount of approximately \$23,000;

j. Protection of island waters by funding the operations and equipment of Islands' Oil Spill Association in an amount of approximately \$130,000;

k. Maintenance of the Parks and Fair in the an amount of approximately \$100,000; and

l. Natural Resources programming in the approximate amount of \$40,000.

A simple majority of the voters is necessary to approve this measure. A "yes" vote is to approve the measure, a "no" vote is to reject the measure.

Argument For

Understand that this is not a new levy, but a continuation of an existing levy that was first passed in 2009 and again in 2014 to provide stability for the support of San Juan County services. This funding is necessary for the continuation of many county-wide programs and services. Reduced spending by the Federal government has forced the County to step up and finance these programs and services. These programs are critically important for many of the people in our county. Some examples are the public health services on Orcas, Lopez and San Juan Islands, Senior Services, including Meals on Wheels, 4H programs for kids, operation of County parks, the Islands Oil Spill Association, and the County Fair. These programs offer great value for the funds expended.

A Yes vote will keep these programs available to County residents, especially seniors who are unable to take care of themselves, and students who will become the future leaders of our communities. A No vote will result in drastic cuts to some of these programs and services and eliminate others entirely. Please vote Yes on this levy.

Argument Against

The justification for the initial Levy Lid Lift was to address needs resulting from budget shortfalls, caused by the worst Recession since the Great Depression. At that time, one would have thought the expenditures contemplated were absolutely essential, but WSU, 4H and Gardening Classes hardly fit the “absolutely essential” definition.

In addition, more money for Senior Meal Services seems to fly in the face of Mullis Center’s claims of declining activity, and their build-up of over \$3,000,000 of liquid Reserves. Lopez Senior Meals has also seen a decline in participation over the last year.

The economy has gotten better here, and elsewhere, since the Recession- much better. However, rather than being eliminated, the asked-for increase in property taxes is a 280% increase in the tax rate per \$1,000/valuation (\$0.22-to-\$0.85)!

Since the time of its last approval, there has been little or no inflation, but instead, there has been steep property valuation increases, and steep increases in overall property tax rates!

This levy increase uses one of the oldest plays in the political playbook. The proponents list a whole bunch of great sounding “Services”, and imply that they will have to be cut if they don’t get this new revenue.

We have all seen this before, with this list of “Revenue Needs”. And remember, just last year, we passed a different Property Tax Increase. It is becoming an Annual Event.

Vote NO on extending the Levy Lid at this time.

The Board of Trustees of the Lopez Island Library District adopted Resolution No. 02 - 2019 concerning an increase to the District's regular property tax levy. This proposition would authorize the District to increase its current levy from \$0.39 to \$0.48 per \$1,000 of assessed value upon all the taxable property within the district for collection beginning in tax year 2020, and allows an increase in the amount of the levy each year thereafter, as authorized by Chapter 84.55 RCW, for normal operation and maintenance of the library.

The Board of Trustees of the Lopez Library District has proposed to increase its regular property tax levy in the year 2020 by way of a one-time levy lid lift of nine cents (\$0.09) per \$1000 assessed value to a total of 48 cents per \$1000 of assessed value, and then use the 2020 amount for subsequent years, subject to the limit factors set out by state law.

The new levy increase is expected to generate about \$565,000 in the year 2020. This is a one-time levy lid lift, and future increases of the levy amount will be subject to the limit factors set out in Chapter 84.55 RCW. The limit factor is typically limited to one percent (1%) plus add-ons including new construction, and subject to maximum limits.

The purpose of this levy is to cover the costs of normal operations and maintenance of the library.

A simple majority of the voters is necessary to approve this measure. A "yes" vote is to approve the measure, a "no" vote is to reject the measure.

Lopez Solid Waste Disposal District Proposition No. 1 Excess Property Tax Levy

The Governing Body of the Lopez Solid Waste Disposal District adopted Resolution No. 25-2019 concerning an excess levy for the district. This proposition would authorize the district to generate \$105,000 by continuing a levy of excess taxes upon all taxable property within the district in an amount estimated to be \$0.10131 per \$1,000 assessed valuation for collection in one year -- 2020 -- for the purpose of funding operations and capital improvements of the district.

Each year, the Governing Board of the Lopez Solid Waste Disposal District has proposed a balanced budget that includes revenue from tipping fees based upon weight or volume, and tax revenue to be paid for with a one-year property tax levy. For the year 2020, the amount of the tax revenue that is budgeted is \$105,000, which is the same amount as in the year 2019.

The governing board has adopted Resolution No. 25-2019 calling for an election to approve the one-year property tax measure to generate \$105,000. If adopted, the property tax for the Solid Waste District will remain the same as the levy from 2019 expires and it is replaced by the a levy of approximately \$0.10131 per \$1,000 of assessed value for taxes imposed for the year 2020. This amount is a replacement of the tax in the same amount for the current year (2019).

The Lopez Solid Waste Disposal District must use the revenue raised for district operations and capital expenses.

A "yes" vote is a vote to approve the proposal; a "no" vote is a vote against the proposal. A sixty percent majority is needed to pass this measure.

Argument For

The solid waste levy must be approved by voters every year.

From January through June, 2019 volumes increased by 17%. We recycled over 151 tons, reclaimed 55 tons of glass, hauled 345 tons of garbage off island, and diverted over a ton of materials per day from landfills to reuse through Take It or Leave It. Over 28,000 customers will visit in 2019. Volunteers are providing over 3,750 hours of support annually.

This year we expanded recycling/garbage hours by 6%, paved, and improved parking, hired a District Manager and Assistant Facility Manager, added security cameras, added safety improvements to the Take It Or Leave It, and initiated a program with the Lopez school to find higher-value uses for recycled plastics.

The Lopez Dump will continue with free self-separated recycling and \$8 per garbage can. Ours is the lowest cost solid waste facility in the county.

Garbage fees alone cannot support our system. Skagit fees increased this year while product prices remain depressed. This levy of \$0.10131 per \$1000 of assessed value will provide us \$105,000 - a small price to pay for a well-managed, award-winning program that helps keep our beautiful rural island healthy and clean.

Vote for Lopez Proposition 1 to keep our Lopez Dump and Take It Or Leave It operating under local control and managed according to Lopez values.

A petition was submitted to the San Juan County Council requesting that the voters consider a proposition to establish the Shaw Island Parks and Recreation District pursuant to the provisions of RCW 36.69.010 et. seq. The district boundaries are all of Shaw Island, Canoe Island and Blind Island.

If approved by a majority of those voting, this measure will establish a parks and recreation district with authority to conduct leisure time activities and provide facilities and recreational facilities of a nonprofit nature as a public service to the residents of Shaw Island.

The district will be governed by five park and recreation district commissioners who must reside in the district and who will be on the same ballot as the question of formation. Those commissioner positions will be established with the persons duly elected if the park and recreation district is approved.

This is a petition for formation of the park and district and separately there is a ballot measure for initial financing of the district. The petition initiating the formation of the requested voter approval for financing the activities of the district with a levy, which is a separate ballot measure.

A “yes” vote is in favor of the formation of a parks and recreation district. A “no” vote is against the formation of a parks and recreation district.

Argument For

The idea for creating a park and recreation district on Shaw Island was born in response to the potential sale of the Portal Property, the land adjacent to the Shaw Island ferry terminal. Although this initial motivation is, at present, no longer an issue, the proposed Park and Recreation District will also be able to accomplish many other things that benefit the Shaw Community: programs for kids and seniors, recreation facilities, community facilities, trails and parks are all possibilities for the future. The District also provides the community with an ongoing public entity for negotiating assistance and cooperation with the County.

By statute, the district will be managed by 5 elected commissioners who are residents and registered voters on Shaw Island. The commissioners will hold monthly public meetings so that members of the community can share their ideas, and advise the commissioners on priorities and limitations for projects and the budget.

Argument Against

This proposed new tax district initially was to create a source of funds to “Save Our Store” by purchasing the property at the ferry landing—referred to as the “Shaw Portal.” However, since the petition to establish the taxing district was filed and approved for the November Ballot, the store has been “saved” and it and the other property have been taken off the market. The opponents now want us to approve this Park District for undefined “recreational” purposes. This should be rejected.

This proposition could impose a tax of 60-cents per \$1,000 of assessed property value. It would place in the hands of three of five commissioners the freedom to decide how to spend \$686,000 in tax dollars without a levy or any further agreement of the island community. And for what? Who knows. The answer is as simple as whatever three commissioners decide.

When the Shaw community met to discuss the proposed tax district on August 10th, none of its primary advocates attended to answer questions to explain their new plans. That should serve as a warning that approving the proposition would both raise taxes and lower accountability.

For decades, Shaw has funded community projects— notably the community center, library/historical society, Shaw Landing, the ball field, and ambulance—through voluntary donations of time and money. Creating this new entity, for no defined purpose, will change the volunteer foundation of the Shaw community.

The petition for the formation of the Shaw Island Park and Recreation District included a provision for financing of initial operational and capital expenses with a regular property tax approved by the voters.

If approved by the voters, this regular property tax is authorized by RCW 36.69.145 in the amount of sixty cents or less per thousand dollars of assessed value. The funds received for the district will be budgeted and appropriated by the commissioners to be elected to the district.

The duration of the regular property tax levy is six years or less, unless voter approval is made for an additional duration.

This excess levy is being proposed for authorization in this vote. Pursuant to RCW 84.09.030, the imposition of the levy will only be made if the district is formed and the boundaries established and if the commissioners set out a request for the imposition of the levy, all as provided by law.

A “yes” vote is in favor of the levy. A “no” vote is against the levy. A three-fifths majority is necessary for approval.

(Author’s note: This unique language of Proposition 2 per RCW 29A.35.210 and RCW 36.60.145 and RCW 84.09.030)

Argument For

The district is funded by a local tax levy of up to \$0.60 per thousand dollars of assessed value. The levy must be voted on by Shaw Island voters and pass with at least 60% approval (60% of the number corresponding to 40% of those voting in the previous general election).

The actual amount of the levy each year is determined by the following process:

1. The Board holds a public hearing on the proposed budget to gather input from the community. They can then modify the budget, or not, and pass a resolution adopting the budget.
2. The budget resolution gives the total revenue needed to operate for the following year and the amount of cash projected to be on hand at the end of the year.
3. The "levy" is the same as the total amount of revenue needed from the budget in total dollars.

The ability to collect the yearly levy must be reauthorized every 6 years. The commissioners may also put a bond on the ballot, if a purchase of a property is agreed on. A bond levy also requires a 60% approval of the voters.

This levy will be managed by the commissioners, elected by and responsible to the community members of Shaw Island (as detailed above).

Argument Against

A levy for .60 per thousand requested by the proponents of the Park District would raise nearly \$700,000 over the six year period the levy would run. The Park District also has access to \$686,000 without a levy. This would leave the Park District with about 1.4 million dollars. 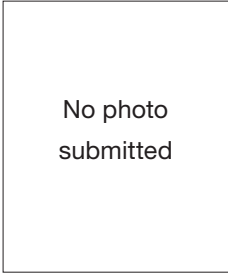
