NOTICE - PLEASE READ

Under Ordinance 12-2012, a vehicle or vessel with a valid, properly affixed decal will be allowed to park or moor according to the posted limits and stated restrictions.

UNDERSTANDING/OBLIGATIONS

I will promptly affix the vehicle decal to the lower portion of the rear window (windshield for convertibles) of the vehicle for which it was issued, in a place where it may be easily seen. I will promptly affix the vessel decal to the bow of the vessel for which it was issued, in a place where it may be easily seen. I will remove the decal(s) if the vehicle/vessel is sold or transferred to another. Should a decal be lost, I will report it to the Public Works Department, at pubwks@sanjuanco.com or 360-370-0500, within five (5) business days. **I understand that my vehicle may not be left unattended for more than 21 days, and that the dinghy dock allows six (6) hours maximum moorage, no overnight moorage, and bow-in tie up only.** Vehicles will be subject to towing if the owner cannot be located. I also understand and agree to abide by the San Juan County Public Works Roche Harbor Restricted Parking and Moorage Zone Policy.

I understand that the county permit parking area is located at the top of the resort, near the gas station as you enter from White Point Road, in the area posted "San Juan County Permit Holders Only," and contains only 20 non-reservable parking spaces.
