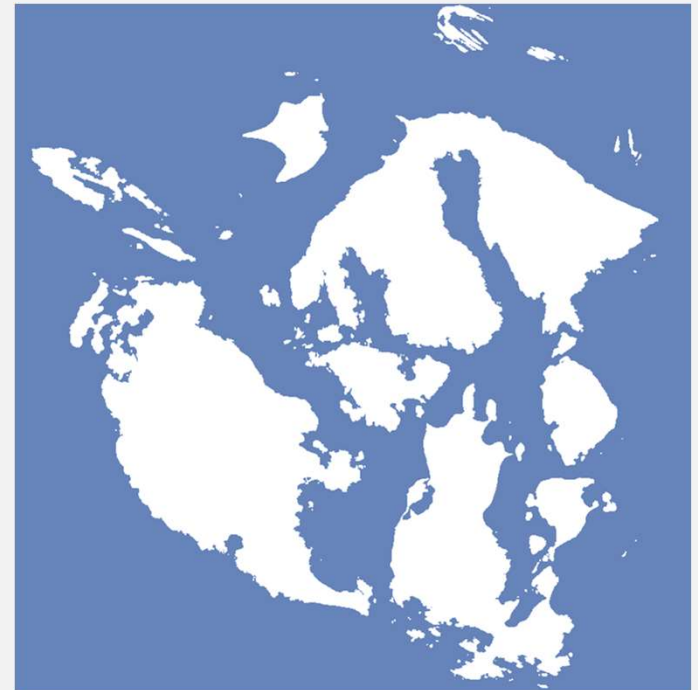

What is the Annual Docket?

- List of requests to amend the Comprehensive Plan (*Plan*), Unified Development Code (UDC) and Official Maps.
- Council decides whether to add requests as projects on the Department of Community Development work plan
- Any interested party may apply January 1 – March 1

Process

- Requests are NOT adopted through the docket
- Requests added to DCD work plan become future projects and will go through a public process
- Planning Commission makes recommendation to Council after June Public Hearing
- Changes not required—local choice

Request 21-0001

Applicant: Thomas Bennett

Request: Allow commercial composting on AG Resource land.

Recommendation: Address this request after the Comprehensive Plan update. Develop performance standards for commercial composting in AG Resource land.

Request 21-0002

Applicant: Orcas Tennis Club

Requests: Allow Indoor Recreation Facilities in the Rural Farm Forest (RFF) land use designation.

Recommendation: If the County Council wishes to pursue this request, this project could be added to a future DCD work program after the Comprehensive Plan update and other higher-priority projects.

Request 21-0003

Applicant: Joe Symons

Request: Add an executive summary and ‘build-out analysis’ to the Introduction of the Comprehensive Plan.

Recommendation: Not recommended. Previously resolved by the 2018 and 2019 dockets. The Comprehensive Plan update fulfils many aspects of the request.

Request 21-0004

Applicant: Department of Community Development

Request: Amend the Flood Hazard Control Regulations to allow wet floodproofing for agricultural and accessory structures.

Recommendation: Do not add this project to the DCD work plan at this time.

Request 21-0005

Applicant: Miles Becker

Request: Consolidate tree regulations in the UDC into one new section specifically for trees. Add general tree retention and protection standards in a new code section.

Recommendation: Staff does not recommend consolidating the tree regulations. Add a tree code project to the DCD work plan after the Comprehensive Plan update

Request 21-0006

Applicant: Eastsound Planning and Review Committee

Request: Make various changes to the development code for Eastsound.

Recommendation: If the County Council wishes to pursue this request, add it to the DCD work plan after the *Plan* update and other higher priority projects.

Request 21-0007

Applicant: Rachelle Ericsson

Request: Allow drive through windows for eating establishments.

Recommendation: If the County Council wishes to pursue this request, add it to the DCD work plan after the *Plan* update and other higher priority projects.

Request 21-0008

Applicant: Alexandra Gayek

Request: Make various changes to the stormwater code.

Recommendation: Add a stormwater regulation update project to the DCD and Public Works work plans after the *Plan* update.
