Ms. Miller proposed a friendly amendment, accepted by the motioners, to add the words "of the public safety tax" in Section 3, second paragraph, after the words "its appropriations" as presented in today's version.

Ms. Pratt proposed a friendly amendment, accepted by the motioners, to add the words "...public safety services" in Section 3, second paragraph, third line, as presented in today's version.

Moved by Mr. Fralick, seconded by Mr. Stephens, to accept and approve Section 4 and Section 5 as presented in today's version with the following changes: reinsert the words "criminal justice" as in the Town of Friday Harbor's request, and add "to protect existing" in the second sentence after the words "by the County," and change the word "purposes" to "services." ALL AYES, MOTION CARRIED

Moved by Mr. Fralick, seconded by Mr. Stephens, to approve Section 5. Ballot Title as follows: "County of San Juan Proposition No. 1, The San Juan County Council adopted Ordinance No. (to be assigned) – 2012 concerning the imposition of a sales and use tax for criminal justice and public safety purposes. This proposition would increase the sales tax in San Juan County by three-tenths of one percent (.003), to be used by the County to protect existing criminal justice and public safety services including law enforcement, prosecution, public defense, courts, probation, victim services, jail, and dispatch services, and by the Town of Friday Harbor for criminal justice and public safety purposes and public works projects." ALL AYES, MOTION CARRIED

Moved by Mr. Fralick, seconded by Mr. Stephens, to approve an Ordinance as amended that provides for the submission to the voters of San Juan County a proposition authorizing an additional sales and use tax at the rate of three-tenths of one percent on transactions as described in RCW 82.14.450 to be used for the criminal justice, public safety and other purposes.
